About the REA Wood Heat Forum

The Wood Heat Forum brings together wood fuel suppliers, biomass boiler and stove manufacturers, installers and distributors, energy companies and developers. It also benefits from members of the wider REA.

We are planning an array of exceptional guest speakers from organisations such as DESNZ, Ofgem, UKPC, Woodsure, Biomass Connect, Supergen Bioenergy Hub, LC Energy, and many more. soon.

We are also working to ensure the best use of biomass recognises that one of the most efficient uses of biomass is in the direct production of heat, with a conversion efficiency approaching 90%. Such efficiencies need to be recognised in future policy discussions concerning 'best use' of biomass and the REA shall be advocating for this to be recognised in the new Government's upcoming Biomass Strategy.
